Dear Ward 43 Residents,

It was a pleasure to see so many of you at my News Years Levee. Scarborough East has so much to offer including the Cedar Ridge Creative Centre where the event was held. The view from the building is a must see especially in the winter. I am very enthusiastic that the Guild Inn Property will soon be able to offer a similar space for future events for us all to enjoy.

I brought three motions to City Council in January. Two dealt with the restructuring of the Toronto Transit Commission and the other dealt with the restructuring of the City's Boards and Agencies. All three items were referred to the Executive Committee. Motion 1: Requested the composition of the Toronto Transit Commission Board of Directors be changed to appoint six members of the public to the Commission. Motion 2: Requested a Citizen Advisory Committee be formed to provide input to the TTC. Motion 3: Requested term limits be set for City Councillors who sit on agencies, boards, commissions and corporations. This provision would provide other Council members the opportunity to serve on these bodies. If you have any questions or comments on the motions please let me know.

Be sure to view section 12 which highlights how you may make a deputation or comment on the 2010 Operating Budget which is to be released on Tuesday February 16, 2010.

Congratulations to the Curran Hall Community Association on a job well done for their inaugural "Winterfest" which took place on Saturday January 23, 2010. The community really came out to mingle in the cold outdoors where there was so much to enjoy including an outdoor skating rink! I was proud to be part of the festival

Guildwood Park precinct meeting took place on Tuesday February 9<sup>th</sup>; Phil Goldsmith, Architect presented the precinct plan to the community. Phase I of the project is ready to commence this year as I was able to secure \$4.2 million within this years budget. The Guild Park Advisory Committee and I have been meeting since 2007 and are supportive of the precinct plan.

I receive a number of e-mails from residents on a daily basis offering their suggestions for our community and city. I welcome all of the comments and look forward to the dialogue.

**Toronto Hydro** has informed me that they will be working in the Coronation / West Hill Community on a Rebuild project geared to improve their electricity system. The work is scheduled to begin in February and end in August 2010. It will involve the construction of the underground electricity system on the south side of Lawrence Ave East between Scarborough Golf Club Rd. (west) and Overture Rd. (east).

I have been advised that the 30 addresses will be affected and that a notice will be sent to residents by Toronto Hydro. This is great news for the residents of Andover Court who exercised their right to petition.

## 7. Guildwood Village

---

**Guild Inn Cultural Precinct Meeting:** Was held on February 9, 2010 at Sir Wilfrid Laurier Collegiate. Phil Goldsmith, Architect presented the precinct plans to residents and City staff was on hand to answer resident's questions. \$4.2 Million is in place for phase I of the precinct plan which will move forward for implementation this year and will take three years to complete. I along with the members of the Guild Park Advisory Committee had reviewed the plan and are supportive of it. Residents are continuing to email me with suggestions for the precinct area, one being for the creation of a skating rink for pleasure skating only. I encourage residents to share their ideas. **Rock the Turbines Dance** will be held on February 13, 2010. The Dance is open to all residents with the goal to raise awareness for Toronto Hydro's proposal to install Wind Turbines in Lake Ontario off of the Scarborough Bluffs. **New Stop Signs in the Guildwood Neighbourhood:** City staff requested for the installation of stop signs at Scarborough Community Council on Tuesday February 9, 2010. The locations put forward were for the intersection of Poplar Road and Dearham Wood/Cumber Avenue, Lyncroft Drive north and south intersections and Forsythia Drive, Tivoli Court and Lalton Place, Tivoli Court and Morna Avenue, and Schubert Drive and Rossini Place. The request was approved.

**Guild Inn & Centennial College:** In August a Letter of Intent (LOI) was approved by Toronto City Council for Centennial College to construct a new home for their Cultural and Heritage Institute. The next step being worked on is

for both sides to sign a long-term lease. The multi-use development in the historic Bickford Residence will include a conference centre, restaurants, and office space.

**Wind Anemometer Update:** It was reported by Toronto Hydro that construction of the anemometer came to a halt last December as the high winds and cold weather did not provide good working conditions to install the device. I have been advised that the work will recommence when the weather settles and is expected to be completed in March 2010. I also spoke to Toronto Hydro in December regarding noise emanating from their generator as well as from their employees on site. The situation is being looked at by Toronto Hydro and I also reported to our Municipal Standards and Licensing Division. If you should experience any noise or disruption please advise my office.

**Toronto Hydro Project:** Residents have approached me wanting to know what they can do to oppose the Toronto Hydro's proposal, as I have advised through my numerous correspondence to the community your provincial representatives must be made aware of our position.

**Property taxes have decreased by more than 2.49% for some:** Notices were sent out to landlords and tenants of properties where the property taxes have decreased by more than 2.49%. Tenants are permitted to reduce their rents after December 31, 2009 as a result of this decrease, and the notices explain how to calculate the rent reduction amount.

**Reminder of Heat for your unit:** The landlord is to provide heat to a dwelling unit that is rented or leased and that is normally heated at the landlord's expense so that a minimum air temperature of 21 degrees Celsius is maintained in all areas of the dwelling unit from the 15th day of September in each year to the 1st day of June in the following year.

## **BACKGROUND TO THE CITY'S BUDGET**

The City has both an operating and capital budget.

The day-to-day operation of City services is paid for from the City's operating budget - the money dedicated to salaries and operating expenses such as rent, fuel, electricity and equipment. The delivery of City services such as police, fire, emergency medical services, TTC, employment services, the new 311 contact centre, waste collection and recycling, libraries, parks and recreation, child care, by-law enforcement and many others are paid for through the City's operating budget. Municipalities cannot have a deficit in their annual operating budgets and must balance their budgets each year - even during a recession - when the needs of the community increase and revenues remain flat or decline. In Toronto, almost half of the property taxes collected in the entire city go toward paying the costs of the three emergency services and the TTC.

In 2009, the City included measures within the operating budget to assist those most affected by the recession. The Your City Can Help program dedicated additional funds to assist residents in keeping their housing and finding work. The City also enhanced property tax assistance programs for eligible seniors and disabled persons.

The 2009 Operating Budget for the City of Toronto was \$8.7 billion.

In 2009, Toronto's residential property taxes for both homes and condominiums continued to be the lowest in the entire GTA. Toronto's government has also reduced the amount of taxes paid by city businesses. Since 2006, the City of Toronto has saved businesses \$190 million in business taxes as part of Council's policy to reduce the overall business tax portion of City-tax revenues.

Toronto City Council froze development charges for two years, 2009 and 2010. The freeze was implemented to support the construction and building industry in the city.

Toronto's government is also rolling out its 10-year \$16 billion capital plan that was approved last December. The plan approved by Council speeds up job creation and the maintenance of City infrastructure by moving more capital spending into the first five years of the plan. More than 50 per cent of the City's 2010 capital budget and 10-year plan will go toward the infrastructure required for the operation, maintenance and expansion of the TTC. The capital budget will pay the cost of major infrastructure for the TTC, including new streetcars. In total, the 10-year capital plan sets aside over \$11.7 billion for transportation in Toronto (including TTC) - more than 70 per cent of the total capital budget.

The City has also approved capital projects for Toronto Water and Solid Waste Management totalling an additional \$9.8 billion, bringing the total 10-year capital plan to \$25.8 billion. Over the 10-year period, these capital plans will create or maintain approximately 300,000 jobs.

## **Council Highlights**

### **City Council meeting of November 30 and December 1, 2, 4 and 7, 2009**

#### **Toronto's sustainable energy strategy**

Council adopted a comprehensive energy strategy for Toronto called The Power to Live Green, which follows through on the City's climate change action plan of 2007 (Change Is in the Air). The Power to Live Green strategy is based on conservation, renewable energy and smart energy distribution to achieve progressive targets for greenhouse gas emission reductions and improved air quality. The strategy involves a four-track process that consists of meeting the energy requirements of businesses and homes; reducing dependence on fossil fuels; investing in green technology and supporting the creation of green jobs and the global marketing of sustainable energy goods and services; and partnering with industry, businesses, institutions, non-profits, other governments, utilities and residents.

#### **Next step for Union Station's revitalization**

Council authorized the City's chief corporate officer to award contracts to proceed with work to revitalize Union Station, and approved the selection of Vanbots as general contractor and construction manager for the project. Council gave several directives, such as ensuring that an environmental assessment of Front Street take into account needs related to taxi operations at Union Station.

#### **Regulation of outdoor signs**

Council approved a new strategy to regulate outdoor signs in Toronto. The strategy includes a consolidated Sign Bylaw that replaces the current sign bylaws in effect across the city; a tax on third party signs; and administrative changes to improve the City's ability to regulate signs and enforce the regulations. This approach to sign regulation reflects the City's goals and objectives for improving what people see in the public realm.

#### **Prime ice time at arenas**

Council discussed the issue of allocating ice time in Toronto arenas and requested more information from eight City-owned arenas that are run by community boards. Council directed the arenas' boards of management to take the following steps: prepare 2010-11 ice time allocations in consultation with City staff; be consistent with the City's ice allocation policy that is adhered to by City-managed arenas; and ensure proportionate shares of prime ice time for various age groups and for girls and boys.

#### **Solid Waste and Water budgets for 2010**

On November 30, Council approved capital and operating budgets for Solid Waste Management Services and Toronto Water. The two capital budgets are part of the City's rollout of its 10-year capital plan for local infrastructure improvements. Details: <http://www.toronto.ca/budget2010>

#### **Preserving the Canada Malting silos**

Council approved a plan to preserve the Canada Malting silos on Toronto's waterfront. Site improvements will provide safe waterfront access to Ireland Park. The second phase of the project will entail creating a master plan for selling a portion of the site for private development and using funds generated by the development to pay for parkland improvements to the site and for the stabilization of the historic silos.

#### **Special meeting December 2 - 2010 municipal election**

At a meeting to discuss the October 2010 municipal election in Toronto, Council decided to implement a contribution rebate program for the election and approved a new bylaw prohibiting corporate and trade union contributions to candidates seeking election to Toronto City Council. In addition, Council adopted a bylaw authorizing the electronic filing of candidates' financial statements. Council also agreed to ask the Province of Ontario to conduct a study of municipal election finance models.

#### **Special meeting December 8 -**

### **City's 2010 capital budget and 10-year capital plan**

On December 8, Council voted to continue investing in the infrastructure needed to keep Toronto moving, approving the City's 2010 capital budget and 10-year (2010-2019) capital plan. The plan approved by Council speeds up job creation and the maintenance of city infrastructure by moving more capital spending on infrastructure projects into the first five years of the plan. The 2010 capital budget and 10-year capital plan total about \$16 billion, with \$2.4 billion earmarked for 2010 and about \$2.5 billion budgeted for each of 2011 and 2012. More details:

### **14. Basement Flooding Protection Subsidy Program**

---

This subsidy is only for the installation of flood-prevention devices such as: a **back-water valve**, a sump pump, back-water valve + pump ,downspout disconnection or pipe severance and capping. The City of Toronto is offering owners of single family, duplex and triplex homes a subsidy to implement flood prevention measures or install flood prevention devices. The program was made permanent via the 2007 Budget process.

Homeowners who have experienced basement flooding or who wish to undertake flood protection activities are eligible for subsidies. Subsidies are subject to available funding in the Capital Works budget and are provided on a first-come, first-served basis until funds become depleted.

Each property owner should carry out a site assessment with a Toronto-licensed plumber to determine the suitability of isolating their property from the sewer system.

The following are eligible upon proper installation, for total subsidy up to \$3,200.00 per property.

### **15. Tree maintenance in Ward 43**

### **Gardiner EA and Integrated Urban Design Study Stakeholder Advisory Committee – SAC**

The purpose of the SAC is a non-political advisory committee to provide an ongoing forum for advice, feedback and guidance to the Project Team at key points during the EA and urban design process. The Project Team includes representatives from Waterfront Toronto, the City of Toronto, as well as from a team of consultants led by Dillon Consulting. Specifically, the SAC will contribute input on the approach and alternatives defined by the Project Team in the *Gardiner Expressway and Lake Shore Boulevard EA Terms of Reference*, once approved by the Ontario Ministry of the Environment.

It is the shared goal of Waterfront Toronto and the City of Toronto to realize the full potential of Toronto's waterfront as a world-class location in which to live, work and play.

This study will examine how a potential reconfiguration of the Gardiner Expressway and Lake Shore Boulevard – from approximately Lower Jarvis Street to just east of the Don Valley Parkway – can contribute to the achievement of the Waterfront Toronto and City goals. ## **25. Office of the Ombudsman**

---

The Toronto Ombudsman's office managed 1,057 complaints and enquiries in its first nine months of operation, processing and closing 91 per cent of them, according to its first Annual Report, released today by Toronto Ombudsman Fiona Crean.

The report, submitted to City Council as a legislative requirement under the City of Toronto Act, sets out the number of complaints, the most common type of complaints, and the areas of the city most complained about. The report also sets out the Ombudsman's strategic plan for the next three years.

Poor customer service was the most common complaint, followed by adverse impact of decisions on residents and a failure to communicate properly with a complainant.

Crean said that publicising the City's customer service standards would be a major step forward. She also noted that as an office of 'last resort' the Ombudsman relies heavily on the Toronto Public Service's own internal complaint processes to resolve issues before they move on to her office.

Of the 29 service areas that Crean reviewed, 13 had good complaints systems in place that were published, seven had good systems that were not published, and the remaining nine either shared no information with the Ombudsman, or had complaints procedures that were inadequate. The two recommendations the Ombudsman is making to City Council for approval are: to ensure that every area of the Toronto Public Service that interacts directly with the public develops and publishes their own complaint systems in 2010; and that the Toronto Public Service publishes its customer service standards in 2010.
