Dear Ward 43 Residents,

Canada celebrates its 142nd birthday this year. Come out to celebrate at Thompson Park, festivities begin at 10 a.m. with the Boy Scouts annual pancake breakfast followed by the 'Movin & Groovin' themed day featuring a variety of up beat music from a number of local musicians; taking place on the main stage at 11am. This item is to be reviewed in the upcoming Fall session at the Licensing Committee.

A fun filled summer season has been scheduled for Ward 43 with many events to attract everyone. A list of all the attractions is listed under section 9, it includes two Farmers & Festival Markets, "The Guild: Alive with Culture An Arts Festival which this year has been extended into a two day event along with many community Barbeques and splash pad openings.

2. Seven Oaks

Spring Clean Up: On May 2, 2009 at 10:00 a.m. I will be joined by community members to clean up the ravine area at the Military Trail Ravine. Invitations have been sent to the area schools, the ratepayer association as well as the area Beavers and Cubs. All volunteers are welcome so please do your part and pitch in. The Seven Oaks Community is blessed with beautiful ravines, unfortunately dumping does occur at these locations. If you believe that additional clean up events should be organized please contact my office so we can get to work. I will be attending the Morningside planting directly after our clean up. You are welcome to join me after our clean up.

Centennial College's Environmental Student Society Planting/Rehabilitation Day is also being held on Saturday May 2nd, 2009 (Rain or Shine). This is their *11th Annual Spring* Planting in Morningside Park. You are welcome to start the day at the Military Trail Clean up at 10:00 a.m. and then join me to attend the planting. If you would like to only attend the planting their registration is at 9:30 a.m. in the last Parking lot. 12:00 p.m. - FREE BBQ for all participants! Planting will take place until 3:00 pm. Even if you only have 1 hour, it would be well spent ☺ please bring lawn chairs and a reusable water/coffee cup.

3. Curran Hall

New Traffic Lights at Slan Avenue and Scarborough Golf Club Road: Notices were sent out to the community regarding the new traffic control lights at Slan Avenue and Scarborough Golf Club Road. The intersection formerly a pedestrian cross over progressively has had an increase of traffic flow creating the need for traffic control lights. My office did receive calls regarding the need for traffic lights and I am sure that they will serve the community well.

New Traffic Lights at Brimorton Road and Orton Park Road: Staff have advised me that the traffic lights which were scheduled for this location for the Fall have been fast tracked and will be installed in early summer. Construction for this location will commence shortly.

Curran Hall Ravine: This spring I will be joined by members of the Curran Hall Community Association to do a walk about to the Ravine trails. The purpose is to address issues with the trail system. If you have any comments to enhance the walking trails please bring them to my attention so that I may review them during the walk about.

East Scarborough Festival Market: Every Thursday afternoon starting June 4th the East Scarborough Festival Market will take place at St. Margaret's in the Pines Parkette. This year's market features fresh fruits and vegetables at a reasonable prices, many vendors selling crafts, second hand items, jewellery and artwork, musical entertainment, contests, dancers, children's activities and BBQ meals. The Festival Market is a weekly event that brings residents from the neighbourhood together to socialize, have fun and participate in healthy activities. It is a partnership venture of Residents Rising, West Hill Community Services, East Scarborough Storefront, Boys & Girls Club of East Scarborough and local churches. This is the 3rd year of the Festival Market and it has been a very successful event for newcomers, seniors, young parents and children. The atmosphere is fun and just like a festival every week.

A Winter Festival in Botany Hill Park for January 2010: Plans for a Winter Festival will commence shortly. We are excepting volunteers to join the Curran Hall Community Association and I in organizing this event. If you are interesting in participating please contact my office at 416-392-4008.

4. Coronation and West Hill

Transportation Services, received a request to investigate the feasibility of installing a pedestrian crossing protection at Morningside Avenue and Gardentree Street/Pixley Crescent. Staff reviewed the request and found that the intersection does not at this time warrant a traffic control signal or a signalized pedestrian crossing. The Traffic volumes recorded over the peak eight hours of a weekday did not meet the technical warrants. The study showed that in an eight hour period pedestrian volume was at 38%: 5 being assisted children, 0 seniors or handicapped persons. During 2003-2007 there have been 3 collisions at this site.

Staff concluded that this intersection has good site lines of approaching vehicles for pedestrians with adequate gaps in the traffic flow. In lieu of this finding staff investigated the possibility of installing a centre island but found that Morningside Avenue did not have the adequate width to accommodate it.

Telecommunication Tower: On March 24th, 2009 Bell Mobility held a meeting to place a Telecommunication Tower on the CNR property located on the south side of the Guildwood GO Station, near Galloway Road. I along with Staff from the Toronto Board of Health attended the community meeting. I had invited Health Canada to attend but unfortunately they have sent regrets, they suggested that residents to view information on their site at: www.hc-sc.gc.ca/ewh-semt/radiation/cons/stations/index-eng.php

Some residents suggested that the notice was not sent out to enough homes. I have spoken to the City Clerks department and have confirmed that the mandated 138 meter radius was covered to residents to notify them of the meeting. I do however agree that the distribution area is very small and did put a motion forward last January to Industry Canada through our Telecommunications policy to have notices sent out to a 400 meter radius which would have covered a wide area. Industry Canada quashed this motion along with a list of other motions I put forward. The one motion which did carry was that all meeting notices be sent by first class mail. The City of Toronto does not have any legislative authority over the placement of these towers. The City can only mandate that a community meeting take place.

You and your neighbours do have the opportunity to make comment to the Federal Government as Industry Canada has authority to receive, review and issue or deny applications. Your local Member of Parliament John McKay. jmckay@johnmckaymp.on.ca, 416-283-1226 is your federal representative and would be able to speak to you on the issue as it falls under his level of government.

As I did with the previous application in the Guildwood community, I can also forward any petitions on your behalf along with a letter supporting the residents position. The letter would also be sent to The Honourable Tony Clement, Minister of Industry, The Honourable Leona Aglukkaq, Minister of Health and your local Member of Parliament John McKay. jmckay@johnmckaymp.on.ca

If you will be collecting a petition please do forward a copy to me so that I may also consider a motion to City Council for an impasse on the location if the number of signatures (households) reaches a reasonable amount for me to be able to convince my colleagues on Council.

One of the questions asked at the March 24th meeting was how was the previous application quashed? The answer is simply, the previous application was on private property and the Church withdrew their interest. Residents had contacted the church and corresponded with them directly. This application is on CNR lands.

June 20th, 12 Noon Splash Pad Opening Mark your calendars for the Eastview Park Official Splash pad opening. Local residents are invited to splash, meet your neighbours, have a hot dog. Please bring your lawn chairs.

June 26th Pow Wow, sunrise ceremony will be at 5 a.m. with the celebrations commencing at 12 noon. Last year the event attracted more than 200 participants to Eastview Park; where the celebrations commenced with the sunrise ceremony. Please plan to join your community in the celebrations.

5. Cornell Community

Town Hall Meeting: I was very pleased to see residents at my town hall meeting on March 26th, 2009. Residents were updated on initiatives in the community and issues were also brought to my attention by residents.

Park Improvement: Residents were updated on the replacement Playground equipment being placed in Cornell Park: Junior and Senior play structures to accommodate more play and a more balanced area for toddlers and older children. The equipment is scheduled to be installed by June, 2009. Residents were also reminded of the new volleyball net and field installed last fall.

Cricket Pitch Request: After receiving requests for the installation of a cricket pitch, I had instructed staff to advise me on the possibility of its installation. Cornell Park is unfortunately not large enough to support an official cricket pitch, the green space is also owned by both the City and the Toronto District School Board. Therefore, any further investigation would require the approval of the school board and local school, without the school support a cricket pitch of any size would not fit.

Upon speaking to the Principal of Cornell Public School my office learned that the school has several soft ball teams as well as soccer teams which play twice a week as well as hold games with surrounding schools. The removal of these two fields to accommodate a cricket pitch would therefore have a negative impact on the schools sports program. A cricket team has been recently included in the school sports. My office was advised that this is a happy set up which accommodates both the sport of soccer and cricket.

Trees for Holmfirth Terrace: Staff have confirmed that trees will be planted along the Boulevard on the north side of Holmfirth Terrace. Currently a brick retaining wall exists along this route, which does not add any enhancement to the community. The new trees will be a welcome improvement to the area.

Community BBQ: I am looking for volunteers for this year's community barbeque to be held on Tuesday June 16th at Cornell Park. This event promises be a fun filled one for the whole family. To Volunteer please contact my office at 416-392-4008.

Community Association for Community East of Scarborough Golf Road: A Community Association founding meeting will be taking place on Thursday April 23, 2009, 7:00 p.m. at the Cedar Ridge Creative Centre located at 225 Confederation Dr. This will be a good opportunity for residents to become more involved in their neighbourhood. Currently there are five community associations in Ward 43. The Cedar Ridge community would benefit in forming one as well.

The purpose of such an association is to create a friendly community environment to support itself as one unified voice when dealing with issues, hosting festivals, working together, as well as bettering the neighbourhood through volunteerism.

I work very closely with all the associations in the Ward, and I have found that they are very beneficial as through them I have been able to organize festivals, spring clean up events, respond to community initiatives and much more. The Associations offer a great opportunity for us to work together to deal with matters directly and quickly.

The meeting on April 23 is the first step in the process of forming an association, to determine if there is an interest from the community.

6. Guildwood Village

Congratulations to Timo Puhakka , the newly elected President of the Guildwood Village Community Association. I have known Timo for many years and will enjoy working with him in his new capacity as president.

Lori Metcalfe has been a tremendous President for the GVCA and I can't thank her enough for all of her dedication to the Guildwood community. Lori has been a strong advocate for the community and has dedicated much of her time to the betterment of the Guild community, and also the Kingston Road/Galloway area. I'll miss sitting beside her at the head of the table at the monthly executive meetings.

Guild Inn Property and Revitalization: The process to dismantle the concrete hotel towers which sit behind the main Guild Inn building will begin on April 20th, 2009. An official media announcement took place on Tuesday April 14, 2009 at 6:00 p.m. on location with Ann Buller, President of Centennial College, Timo Puhakka, President of the Guildwood Village Community Association, and Sandy Muir, Chair and Janet Heise, Director of the Guild Renaissance Group to mark the beginning of a new phase for Guild Park & Gardens, and a new relationship with Centennial College. The News Release can be viewed on my website at www.paulainslie.com.

Construction crews are beginning the process from inside the building. Safety precautions have been put in place for the resident's safety. Please be cautious if you are walking on the grounds and keep a distance from the construction area. I have been advised that the take down process will be within a three month period. The removal of the hotel towers marks the success of the first phase in the project marking the beginning of the Guild Inn Grounds revitalization. Residents have volunteered many hours of their personal time and energy to the Guild Park Advisory Committee, It has been a pleasure to work with them and I look forward in continuing our work as we begin the next phase of the project.

Centennial College is committed to work with the City to revitalize the main building. I will be hosting a community open house for residents after the negotiations are completed to display the Centennial College project, as well as the City of Toronto Cultural Precinct . Community involvement has been in place for this phase since its inception and will continue as we move forward.

The Guild: Alive With Culture Arts Festival: Building on the success of last years event, residents can look forward to a two day event this year. Currently, plans are well underway for a larger more exciting event to return to the Guild Park & Gardens on August 15 & 16th this summer. The organizational committee has been working hard to see a larger group of exhibitors in place, a range of musical and literary entertainment, as well as an enhanced children's area. With the demolition of the hotel tower, we even hope to have a hot air balloon which will be able to get off the ground! This year also sees the return of Lord Simcoe and our Town Crier! Returning as well will also be a tour of the many different architectural features of the grounds, but this year it will be self-guided.

New Stop Signs: After several calls to my office and to the transportation office from Guildwood residents several new stop signs were installed in the Guildwood Community. City Staff investigated the complaint area and identified six three-way intersections and five intersections with posted yield signs which were determined to be in need of proper signage for both vehicle and pedestrian safety. Once locations have been identified the City must act on them for liability reasons. Street stop signs at eleven intersections have been installed at Bournville Drive and Earswick Drive, Catalina Drive and Bledlow Manor Drive, Catalina Drive, and Bournville Drive, Grandor Court and Prince Philip

Boulevard, Rowatson Road and Fareham Crescent (north intersection), and Rowatson Road and Fareham Crescent (south intersection), Avonmore Square and Prince Philip Boulevard (north intersection), Avonmore Square and Prince Philip Boulevard (south intersection), Bournville Drive and Prince Philip Boulevard, Prince Philip Boulevard and Sonneck Square (north intersection), and Prince Philip Boulevard and Sonneck Square (south intersection).

Guildwood Village Farmers' Market: launches this June at the historic grounds of The Guild Park & Gardens. The market season is June to October, Thursdays 2pm-6pm. www.marketsbythebluffs.com. I am very enthusiastic about this event taking place on the grounds of the Guild. This is the same market which is currently taking place at Warden Ave & Kingston Rd. They were good enough to take part in my Guild: Alive With Culture Arts festival last summer. They are bringing many of same farmers to our area.

Wind Turbines: To date there have been three public meetings about the Toronto Hydro Renewable Energy's proposal to construct wind turbines off of the Scarborough Bluffs. Its unfortunate the provincial government with the creation of their latest green energy legislation, spent quite a bit of time labeling Guild area residents as "NIMBYs" for their concern about this project. While there are a number of environmental concerns I have about this project, my chief one has to do with economics. I have yet to see a viable economic case for the construction and use of wind turbines. As Toronto residents, we are the largest shareholder in Toronto Hydro. This project is not a viable use of our tax dollars. I think there are many other methods to be "green, including solar power, and a variety of successful energy conservation programs available. None of which Toronto Hydro has any interest in looking at.

Telecommunications Towers: This has been a divisive issue for the community over the past year and a half. It began with Bell Mobility wanting to place a very tall relay tower in the middle of the Guildwood community. Since then, I've been using what little authority I have to find a more suitable place for a tower. As a municipal politician, I have a very limited amount of resources to find viable solutions. Industry Canada, a federal agency has complete authority over these towers. Telecommunications companies aren't even legally required to come to City hall to apply for a building permit for them. I attended a community meeting last week to review the latest location on the south side of the CNR tracks, just west of Galloway Rd, in the forest. (the information is in the Cedar Ridge section of this report)

Guild Summer Concerts: The City of Toronto's Guild Summer Concert Series will return to the Guild Inn Greek Theatre for performances on June 11th, 18th, and 25th. Further information on the performers will be posted closer to the date.

The Guildwood Community Association has sent a letter to the Minister and Toronto Hydro confirming their opposition to the Proposed Wind farm in Lake Ontario off the Scarborough/Toronto Bluffs.

During a recent meeting with Toronto Hydro the issues surrounding the turbines economic liability as well as all of the communities concerns with health, noise, birds and animal species, I reaffirmed to them that they have failed to substantiate their position in installing the anemometer or proposed turbines at this location. I continued by advising that the opposition of the community has not been realized by their corporation and that they need to have community backing for any projects for them to be truly successful. The “we know better than “, attitude, simply does not work here or anywhere. Many jurisdictions in Canada and the United States are facing our battle.

On Sunday March 29th, 2009, the grass roots community organization Save the Toronto Bluffs held an open house: Community roundtable synopsis at Sir Wilfrid Laurier CI. WIND POWER: GREEN ENERGY OR GREENWASHING - posted for the Save the Bluffs Community Organization.

Ethanol production used to be the sweetheart of the **uninformed** segment of the green movement. It was realized after the damage was done, that taking food away from people to feed our cars was irresponsible. Is wind power another ‘ill conceived cure’ for Ontario’s energy need?

Wind Power Cannot Provide Large Amounts of Useful Electricity

1/ Because wind blows irregularly, turbines produce a fraction of their theoretical output. The CNE turbine has only a 12% productivity and Pickering 18%.

2/ Wind does not blow in relation to precise human schedules. Wind power is often available when it is not needed and unavailable when it is most needed. Think for example of hot humid summer days when we need the most power to fuel our air conditioners, and there is absolutely no wind for weeks at a time. **No wind, no power!**

3/ Large amounts of energy, cannot be stored for future use.

Wind power is Not Green

1/ Because production of useful energy from wind factories is so tiny and unpredictable, conventional generating plants have to be immediately available in spinning reserve - running at less than top efficiency to supply electricity when the win drops or disappears.

2/ Wind power has **not** resulted in the closing of even one coal plant anywhere in the world. In fact countries who have invested heavily in wind power, such as Germany and Denmark, continue to build new coal plants.

Are Wind Companies Corporate Welfare Bums?

Wind power is not free. Just follow the money. The wind energy business is a ‘fool’s paradise’ relying on government subsidies, tax breaks and guarantees by the government that the power will be purchased at a rate twice the cost of other power.

Developers rush to claim sites for their turbines. Why? Because there's so much money to be made that it doesn't really matter whether the turbines run efficiently or not. Where does the money come from? Do you really have to ask? Check your property tax bill. Check your income tax bill. Check your Hydro bill. Yes, it comes from you. And you never get it back: it goes to the developers.

Wind Factories are Deadly for Birds and Bats

The Bluffs area is a known 'fly-way'. Numerous worldwide studies have demonstrated the serious risks to wildlife provided by wind turbines.

Noise Radiation

Blindly accepting the cliches offered by wind power developers can be dangerous to health and quality of life. The noise and vibration produced by wind turbines is extremely complicated and needs to be thoroughly studied and understood. Locating wind turbines close to families demands a precision, accuracy, and certainty of acoustic prediction and calculation that is just not available to the wind energy engineers and acousticians.

Here's what we know:

- 1/ Modern wind turbines generate high sound levels, close to 100 dB from each of 8 points on the turbine (blade, gear box, hub, generator...). To put that in perspective, the pain threshold for the human ear is 130dB.
- 2/ Sound travels much further over water than on land.
- 3/ Germany which is often quoted for its investment in wind energy, is launching a wind turbine project in the North Sea which will be built 40 km from the shoreline; as opposed to the totally inadequate 2 Km setback proposed by Toronto Hydro.
- 4/ The wind industry evaluates sound in self-serving ways. Instead of measuring the full spectrum of noise emanating from wind factories, it focuses on higher frequencies and understates the importance of lower frequencies (infrasound); the very frequencies that are most damaging to humans.

Health Effects of Wind Turbines

- 1/ There are frequent, often debilitating symptoms experienced by adults and children while living near large industrial wind turbines. Symptoms include sleep disturbance, headaches, tinnitus, ear pressure, dizziness, vertigo, nausea, visual blurring, tachycardia, irritability, problems with concentration and memory, and panic episodes associated with sensations of internal pulsation or quivering which arise while awake or asleep.
- 2/ These symptoms are not statistically associated with pre-existing anxiety or other mental health disorders. In other words, these people are not crazy.
- 3/ Not everyone near turbines has these symptoms. There are differences among people in susceptibility for any risk factor (including smoking).

In summary, wind turbines are the problem not the answer!

Wind turbines are the most damaging, expensive and fiscally irresponsible solution to Ontario's energy need. **Industrial wind factories are unfit to be in our back yard, or**

in anyone else's back yard. We, the governed and those who govern, should adopt the physicians' oath: First, do no harm.

12. City of Toronto Council Highlights

Toronto City Council meeting of February 23 and 24, 2009

Freeze on Development Charges

Council adopted a structure for development charges, freezing the fee at current levels for the next two years (until January 31, 2011). The intention is to give the development industry some predictability and to help protect Toronto's prosperity. A new development charge bylaw will come into effect on May 1, 2009. It will replace the existing bylaw and will allow the City to continue to collect development charges to pay for a portion of municipal growth-related capital costs for municipal services. The new bylaw provides for a multi-year phase-in of updated charges on housing construction starting in February 2011 if construction activity reaches certain pre-determined levels - with exemptions such as affordable rental housing and industrial development. Toronto Beaches Plan

Council endorsed a plan to improve and enhance the City of Toronto's 11 swimming beaches as a key feature of the waterfront. The action plan identifies steps to improve water quality at the three City beaches (Sunnyside, Marie Curtis East and Rouge) that tend to have the poorest water quality. At Sunnyside, the City will undertake a three-year pilot project to enclose part of the swimming area at the beach in order to provide acceptable recreational water quality. The long-term vision is to have all Toronto swimming beaches rated at the international Blue Flag standard or better. The Municipal Code does not permit dogs on Blue Flag designated beaches. Council asked staff to look at ways to address concerns that dog owners/walkers have voiced about access to Kew-Balmy Beach. Legacy Projects for Pan Am Games Bid

Council approved the investment of \$49.5 million to create an infrastructure of new and revitalized athletic facilities that will benefit priority neighbourhoods and leave a legacy for Toronto. The City's \$49.5 million investment, tied to the Toronto area's bid to host the 2015 Pan American/ParaPan Games, is expected to leverage about \$198 million from the provincial and federal governments to complete the necessary work at six City-owned athletic sites. The Toronto region's bid is competing with bids by Lima, Peru and Bogota, Colombia to host the 2015 games. (News release dated February 23: <http://wx.toronto.ca/inter/it/newsrel.nsf>)

Appointees to Build Toronto and Invest Toronto

Council confirmed the appointment of boards of directors for Build Toronto and Invest Toronto. The two new boards of talented citizen appointees are at the centre of the City's strategy to enhance Toronto's economic competitiveness. Invest Toronto has a mandate to engage with the private sector to promote Toronto as an investment opportunity. Build Toronto's mandate is to work with private and public sector partners to unlock the value of underused City real estate, stimulating the creation of desirable jobs and regenerating neighbourhoods. Council approved the early opening of 13 outdoor ice rinks across the city next fall to start the 2010 skating season. The City will schedule those rinks to open at the same time as the rink at Nathan Phillips Square in November. The rinks are Rennie Park Rink, Sir Adam Beck Rink, Sunnydale Rink, Dufferin Grove, Hodgson Rink, Kew Gardens Rink, Regent Park South Rink, Mel Lastman Square, Broadlands Community Centre, Glen Long Community Centre, Irving Chapley Community Centre, Albert Campbell Square and West Mall Rink.

Yonge-Eglinton Centre

Council took steps to establish the planning and zoning framework needed to proceed with the revitalization of the Yonge Street-Eglinton Avenue area, specifically the southwest quadrant of the intersection. The revitalization is to include investment in public transit infrastructure, the provision of major office space and employment, promotion of sustainable green development on the Eglinton TTC bus terminal lands, and improvement of the public realm and local amenities.

Banner Background from Marg Maskell of Clarington

In Feb of 2006 our nephew, Corporal David Allison, came to visit us from New Brunswick to say good-bye as he was going to Afghanistan. He went back home and left shortly after for his tour of duty. David arrived in Kandahar and about 4 weeks later, 6 men out of his troop the R C R were killed. I will never forget standing on the bridge when these 6 men passed travelling on the Highway of Hero's to Toronto. My husband and I decided that we would go down east to visit his family and while there I was invited to a red rally. It was there that I met some of the 6 families. The feeling was something that you just can't describe. I was introduced to these people and not knowing what to say I just simply asked "What can I do to make things better"???? The answer was simple--- wear red on Fridays and tie a yellow ribbon some place on your property where it could be seen by all. We returned home and I made a yellow ribbon and place it outside for all to see. I worked at A&P and approached the manager to see if we could possibly wear red shirts on Fridays, management agreed. The shirts where purchased from Trenton and we

were on our way. Then the unforgivable happened----- Trooper Darryl Caswell---one of our own was killed in Kandahar in June. The people standing at the bridges increased in numbers. As more travelled down the Highway of Hero's the larger the crowds grew. I just knew that I had to do something else to show that the people and towns really Support the Troops, and the banner came to mind. I phoned Scott Taylor who made the banner and told him what I wanted to do and what I want on the banner and he sent me 3 choices of similar designs. It was easy once I saw it—Scott!-- had made just what I wanted, it said it all and thus the banner was born. There was a lot of conversation back and forth between the Legion(John Johnson), Bev Oda, John O'Toole, councillors and Scott. After going to council it was finally agreed the banners would hang in Bowmanville and in different towns in the Municipality of Clarington: 24 in all. Other people are now ordering the banner and my hope is that it will appear all across Canada...A special thank you to the one person who made it all happen for me. I had a dream and Scott Taylor "The Artshack" made it happen and the dream continues.....

19. Project Fusion

In the early morning hours of Wednesday, April 1, 2009, in excess of 1,000 police officers

executed 161 search warrants throughout the GTA resulting, so far, in 125 arrests. In the course of executing these pre-dawn raids, police officers from various services from across

Ontario, including 38 tactical units, were utilized.

Project Fusion began in mid-2008, and focused on a series of violent crimes dating back to

2003. It is alleged that those involved in this investigation are leaders, members and/or associates who participate in two criminal organizations that operate in concert with each other, known as the “MNE” (*Markham Road/Eglinton Avenue East*), and the “400 Crew”

(400/McCowan Road). They’re located in the southeast area of Toronto however their criminal

activities are not limited to this area but cross into Durham Region and throughout the GTA.

The focus of this investigation was not only the alleged criminal organizations MNE and 400

Crew, but the people alleged to be responsible for the supply of firearms and illegal drugs to

these criminal organizations.

This project was a joint investigation combining the TPS Integrated Gun and Gang Task Force, Durham Regional Police Service, Ontario Provincial Police - Organized Crime Enforcement Bureau, the Canada Border Services Agency, the TPS Firearms Enforcement

Unit, the TPS Drug Squad, the TPS Proceeds of Crime Unit, as well as Divisional Policing

Command.

A total of 100 homes and 61 vehicles were the targets of the search warrants in the following

jurisdictions: York Region: 5 Peel Region: 5 Durham Region: 12 Toronto: 78

The Toronto anti violence strategy has been making quite a difference in the Scarborough area, in identifying crime and disorder issues, reducing violence and making neighbourhoods safer.
