Dear Residents of Ward 43,

I'm very happy all the Toronto Public Library branches reopened on Friday March 30 at 10:30 am, as a settlement was reached with the Toronto Public Library Workers' Union Local 4948. The Library Board approved a 4-year agreement with the Toronto Public Library Union Local 4948 bringing back all library services to all branches.

As Chair of the Toronto Public Library, I was very pleased that we were able to reach an agreement. The agreement is fair to all the employees and is affordable to you while efficiently delivering excellent library services that we all expect.

The Agreement include a modest wage increase in the second, third and fourth year of the contract. These increases are 0.225 per cent (2013), 1.75 per cent (2014) and 2.25 per cent (2015). There is no wage increase for 2012 but employees will receive a lump sum payment of 1.5 per cent to be paid on January 1, 2013. Also included is new Job Security provision which states that there shall be no layoffs of full-time and part-time employees with 11 years' seniority or more. The Library's seniority is an integrated list of full-time, part-time and Page employees – which is unique to the Library – and so under the Library's provision, 59 per cent of employees do not have job security protection.

The Workforce composition for the Toronto Public Library is 75% of the workforce at the library is female, 70% full-time and 30% part-time. The library has approximately 400 librarians. Branches are open evening and weekend hours making it necessary to have part-time staff available to assist with staffing this kind of schedule. Many of the part-time staff are students and others who are looking for flexible hours and scheduling.

Weekly 380,000 Torontonians visit library branches in neighbourhoods across the city, and borrow more than 660,000 items. The yearly snapshot demonstrates 19 million people to its branches, and lends over 33 million items.)

Overdue materials during the labour disruption will not be charged to residents, as long as they became overdue during timeframe of the disruption. You will have 2 weeks to return overdue materials without being charged fines. Don't hesitate to contact me on any municipal matters. Transportation Study

Extend the School Bus Loading Zone Two Metres Further East # 370 Military Trail at Highcastle Public School. link
Further to a request and meeting with the principal of Highcastle Public School, Mr. Lindy Hussey,
Transportation staff has reviewed the area, the corresponding parking by-law regulations and road operations.

Specifically, the principal requested that the School Bus Loading Zone be extended an additional two metres further east to accommodate three school buses. The School Bus Loading Zone extension will allow the school buses to properly position their doors at the new concrete pads, installed in front of the school, and prevent the buses from protruding into the 30 minute permissive parking 8:00 a.m. to 4:00 p.m., Monday to Friday regulation area.

Based on our review, we have concluded that extending School Bus Loading Zone is justified at the subject location. Transportation staff will recommend the extension of the east limit of the School Bus Loading Zone two metres further east and the reduction of the west limit of the Permissive Parking regulation signage / No Parking regulation signage by two metres to prevent passenger vehicles from parking within the School Bus Loading Zone.

A report to Scarborough Community Council requesting authority to modify the limits of the school bus loading zone and adjacent parking regulations will be tabled. Accordingly, once approved, the "School Bus Loading Zone" limits and other adjacent signage will be relocated as soon as scheduling and budget permits.

Since this is a school area, Military Trail has been included in the Transportation Services Division's "Watch Your Speed" Program for 2012 and the unit is tentatively scheduled for September 10 to 14, 2012. The "Watch Your Speed" Program involves the temporary placement of a small trailer or display board on the boulevard (containing a radar unit and a display unit), which displays the driver's operating speed and the posted speed limit. The purpose of the program is to make drivers aware of

the speed they are travelling, thereby reinforcing the existing speed limit. Our study results at other locations where we have utilized this device revealed that it has had a positive impact on reducing vehicle operating speeds.

Transportation Study

Review of Sight Lines at Ellesmere Road and Helicon Gate/Scarborough Golf Club Road

Transportation services have completed a review and have concluded that the issue of sight line restrictions for southbound and westbound right-turning traffic is not indicative of a safety problem at this time, and sufficient stopping sight distance is provided for southbound and westbound traffic.

They have reviewed the minimum sight distance requirements and potential conflicts of southbound and westbound of right-turning vehicles not able to see pedestrians or cyclists crossing the road. Vehicles stopped behind the stop bar at this signalized intersection may not have an unimpeded view of traffic after the installation of the new bicycle crossing lane. However, at this intersection at a red traffic control signal light indication, southbound and westbound rightturning vehicles must first stop behind the stop bar and then only proceed when it is safe to do so like all other intersections in the City. After having met this obligation, motorists may carefully/slowly proceed past the stop bar to increase their visibility of on-coming traffic.

To identify existing conditions, southbound right-turning studies were conducted during the morning and afternoon peak periods. The results of these studies confirmed that there were a total of 36 and 18 vehicles during a.m. and p.m. peak study periods respectively. No rightturning movement conflicting with pedestrians or cyclists during this study.

To provide motorists with additional warning of the cyclists crossing, Transportation Services has modified an earlier version warning sign i.e., "Turning Traffic Must Yield to Pedestrians" to "Turning Traffic Must Yield to Pedestrians & Cyclists". These modified sign was installed in 2012.

The details of our study, including a three years review of the Toronto Police Services collision records, are outlined in the attached technical summary.

Transportation Study:

Milford Haven Drive & Greenock Avenue, Request for Traffic Calming

Request to install traffic calming measures along both Milford Haven Drive and Greenock Avenue. Since this request was not received accompanied by a petition signed by a minimum of 25% of the affected residents along both streets, Traffic Operations cannot process this request until such time as the noted petition is received. This condition has been set in the Warrant Criteria for Traffic Calming. Other options to

engage the traffic calming process would involve the Ward Councillor holding a public meeting and subsequently directing staff or by the Ward Councillor conducting a survey to gauge the will for traffic calming along a particular street(s).

A brief review of the Toronto Police Services collision records along both streets north of Slan Avenue from January 1, 2008 to date (approximately October 15, 2011) shows that of the four reported collisions, none involved speeding motorists as cited contributing factors (two involved reversing errors and two involved property damage to on-street parked cars).

As an alternative, the extensive process of traffic calming can often times be averted by a more immediate and direct method suggested by the Toronto Police Services.

This method involves concerned area residents noting obviously speeding motorists by taking their license numbers and description of their vehicles and the drivers to the police division such that the police can pursue an appropriate follow-up action. This method is often times more immediate/effective and a prudent use of resources at deterring the few speeders in a neighbourhood versus other approaches that affecting all area road users.

Transportation Study Report

On-Street Parking Blocking the Underground Garage Driveway/Townhouse Complex

10 Rodda Boulevard Link

Transportation Staff have advised that they have completed a review concerning on-street parked vehicles blocking the sightlines for vehicles exiting onto Rodda Boulevard from the underground parking driveway to 10 Rodda Boulevard.

Based on our review, Transportation staff has confirmed that on-street parked vehicles do indeed block sightlines at the driveway to the underground parking ramp to 10 Rodda Boulevard. Traffic Operations staff recommends that No Parking Anytime regulations be installed 10.5 metres north and 10.5 metres south of the subject underground driveway on the west side of Rodda Boulevard in order to maintain clear sightlines for vehicles exiting the driveway. Currently vehicles are parking on the west side of Rodda Boulevard, directly beside the townhouse driveway to the underground, and are obstructing sightlines for vehicles and pedestrians.

Typically when parked vehicles cause sight line issues at a busy driveway we would install No Parking Anytime regulations within nine metres of the driveway. In this particular case there is a 1.5 metre wide pedestrian pathway on either side of the underground parking ramp driveway. In order to also maintain clear sightlines for pedestrians, the start point for the nine metre No Parking Anytime regulation will begin on either side of the pathways located directly adjacent to the driveways. The existing parking regulation on Rodda Boulevard consists of an unposted "default" three-hour limit. The proposed parking regulations will result in the loss of approximately two on-street parking spaces. However, ample on-street parking is still available on both sides of Rodda Boulevard north and south of the subject driveway.

A report to Scarborough Community Council will be tabled requesting authority to implement the No Parking Anytime regulations within 10.5 metres south of the subject driveway. Accordingly, once approved, the No Parking Anytime regulation signage will be installed as soon as scheduling and budget permits. 11. Council Highlights

Council Highlights

City Council meeting of March 5 and 6, 2012

Council Highlights is an informal summary of decisions made by Toronto City Council. The City Clerk provides the official documentation at <http://www.toronto.ca/council>.

Change to Toronto Transit Commission

Council approved a new governance structure for the Toronto Transit Commission. A commission of seven Council members replaces the previous nine-member transit commission. Councillors Maria Augimeri, Raymond Cho, Josh

Colle, Glenn De Baeremaeker, Peter Milczyn, John Parker and Karen Stintz were chosen as the seven commissioners, with Councillor Stintz the TTC Chair. The composition of the transit commission will increase at the end of October with the addition of four citizen members, who will be appointed by Council at that time.

Sale of Toronto Community Housing properties

Council approved the Toronto Community Housing Corporation's proposed sale of 56 of its vacant houses containing 64 housing units. The sale is part of TCHC's strategy to address state-of-good-repair needs in its portfolio. Proceeds from the sales will fund capital repairs to TCHC's stock of multi-residential buildings.

Permit fees for sports fields

Council supported a motion calling for staff to report at Council's next meeting (April 10) on a way of offering relief to sports groups that are having financial difficulty paying the fees for sports field permits. The City will work with individual permit holders to set up flexible payment plans for this year's fees so they can continue their regular season play. Until this year, the fees were only charged to players 18 years and older. Sports field fees now also apply to players under 18.

Fund for community development projects

Council authorized the creation of a Community Development Reserve Fund to receive cash contributions for joint ventures in support of community development projects. The first project is community development work in the Weston-Mount Dennis neighbourhood. The City has received two contributions - up to \$500,000 from Toronto Community Foundation for the Mount Dennis project, and \$1.1 million from Metrolinx.

Support for neighbourhoods

Council adopted the Toronto Strong Neighbourhoods Strategy 2020, designed to guide the City's neighbourhood-focused work. The strategy is intended to ensure that every Toronto neighbourhood has the public, private and community infrastructure required for equitable resident opportunities. In addition, the strategy emphasizes that a neighbourhood perspective should routinely inform municipal, regional, provincial and national policies, programs and funding priorities.

Pedestrian crossovers

Council agreed to make the stopping prohibitions uniform at all pedestrian crossovers (crosswalks) on Toronto streets. The prohibition makes it illegal to stop a vehicle within 15 metres of a crossover on the approach side even if there are no signs stating the prohibition. Vehicles parked near a pedestrian crossover can create a safety hazard by reducing the sight lines of drivers approaching the crossover and of pedestrians preparing to use it to cross the street.

Request for exemption from trade agreement

Council decided to ask the Province of Ontario to exempt Toronto from a comprehensive economic and trade agreement that is now under negotiation by Canada and the European Union. Toronto joins many other municipalities in seeking the exemption. Council also voted to ask the Canadian government to protect Toronto from any restrictions the trade agreement might otherwise impose on the City's ability to create local jobs, protect the environment and provide programs/services as it sees fit.

Toronto workforce strategy

Council endorsed Working as One: A Workforce Development Strategy for Toronto. The strategy sets out a framework for planning and managing employment services, and for delivering them to employers and unemployed or underemployed residents. Working as One provides a basis for integrating employment services in Toronto. The strategy is designed to work closely with the City of Toronto's economic development strategy to support people, connect businesses and strengthen communities across the city.

Protection of groundwater purity

Council agreed to direct staff to review existing mechanisms for testing soil that is leaving Toronto-area development sites, and to make recommendations for greater consistency in soil-quality testing, especially at brownfield (formerly industrial) sites. Some soil from Toronto development sites is reportedly being dumped onto Oak Ridges Moraine land - which is a major source of Toronto's water - without being remediated to remove chemical contaminants.

Canadian National Exhibition

Council approved terms and conditions for making the Canadian National Exhibition Association independent from the board of governors of the City's Exhibition Place. Council's action will permit the Exhibition Place board to execute a master agreement with the CNE to make the CNE fully independent in 2013. The annual CNE is the largest exhibition in Canada and one of Toronto's premier summer events.

12. Collective agreement with Local 79

Services to public continue as 11,500 full-time and 1,150 part-time employees accept City's final offer

Two significant bargaining units of the City of Toronto's inside workers voted Wednesday to accept the City's final offer made during bargaining with CUPE Local 79 on the weekend. The Full-time and Part-time B units of CUPE Local 79 and TCEU Local 416 (CUPE) have all now ratified their collective agreements. These employees represent approximately 90 per cent of the full-time equivalent employees represented by CUPE.

The City is pleased that it has resolved two long-standing issues. Employment security is no longer a matter in dispute between the parties as the job security provision of 15 years of seniority has only ever applied to permanent full-time employees, who have now ratified their collective agreement. In addition, the ratification of the full-time unit also now means that the City has successfully eliminated the unnecessary administrative 30-minute shift overlap in the Long-Term Care Homes and Services Division.

The other two units (part-time Recreation Workers and part-time Long-Term Care Homes and Services Workers) voted yesterday to reject the City's offer. The part-time employees in the Long-Term Care Homes and Services unit will proceed to binding arbitration and do not have the legal right to strike.

The next step in the process is for City Council to meet in a special session to consider the two agreements ratified by the Local 79 members. The date of the meeting will be announced as soon as possible. Details of the agreements will be posted on the City's website when they have been approved by Council.

In terms of the part-time recreational workers, the City intends to meet with the union to hear their outstanding issues however it is important to note that the other employee units have just ratified their agreements and they are similar to the Local 416 agreement ratified last month.

Local 79 has suggested that if the City implements terms and conditions of its final offer, it could lead to the union calling a strike. The City's contingency plan is posted on its website at www.toronto.ca.

13. 13th Annual Doors Open Toronto May 26th & May 27th 2012

Over the past decade demand has increased rapidly from building owners, architects and developers wanting to showcase their buildings. For this reason, Doors Open Toronto has created specific criteria that will help organizers select the buildings that will be showcased.

Preference will be given to buildings that meet the following criteria: Are not usually open to the public or have areas not usually open to the public, but have some significant architectural features and/or have historical, social, as well as cultural significance to the city. Are open to the public, but have some significant architectural features and/or have historical, social, as well as cultural significance to the city. (ex: churches, banquet halls, theatres)

- Buildings that can commit to opening their doors for two full days, 10 a.m. to 5 p.m.
- Buildings that are celebrating significant anniversaries
- Buildings recognized by heritage, urban design and/or architectural awards
- Buildings with significant original interior features and/or successful adaptive reuse features
- Buildings that feature contemporary design excellence and/or innovative green/sustainable/LEED elements
- Buildings in destination clusters (several venues in one area)
- Buildings representing the cultural diversity of Toronto

In addition to the above criteria: Buildings that can demonstrate enhanced or thematic programming will be given preference (Architect's tours, children's activities, live music or theatrical performances) Theme for 2012:

Every building has a story to tell and this year's theme is: "200 years of Building the Urban City". We will ask all building participants to focus on "city builders", the people and personalities that are associated with our city's history in celebration of the bicentennial of the war of 1812. . We wanted to make a strong connection to this celebration and connect the present day architecture of the city. The ending of the war of 1812 was a catalyst for all kinds of city building.

As we all know every building in Toronto has a story and is often all associated with a major personality. The Doors Open program will deal both with sites that had a significant impact on the war itself, but more importantly it can also deal with "more" - the buildings and the city builders associated that have had an impact on modern day Toronto.

16. Government support key to low-income homeowner success: survey

According to Making Homeownership Happen – Government funding is essential if low and moderate income rental households are to succeed in owning their own home, Success through Partnerships, a first-of-its-kind survey conducted by the City of Toronto's Affordable Housing Office.

Almost three-quarters of respondents said they would not have been able to buy a home without financial support from governments, according to the Making Homeownership Happen - Success through Partnerships.

Almost four-fifths of those surveyed are satisfied with the transition to owning from renting. Some 70 per cent said their financial stability had improved or was expected to improve.

Some 14 per cent of those surveyed had been on the social housing waiting list or were Toronto Community Housing Corporation (TCHC) tenants before becoming homeowners. About 12 per cent earned less than \$30,000 a year and 64 per cent earned between \$30,000 and \$70,000.

The 31-question survey was conducted between September and November, 2011. Some 236 people filled out surveys - a 40 per cent completion rate. The surveys were distributed by six organizations which work to provide affordable homeownership: Habitat for Humanity Toronto; Home Ownership Alternatives Non-Profit Corporation; the Women's Religious Project; Artscape; Miziwe Biik; and Toronto Community Housing.

19. Restoration of Highland Creek within Valley Segment 4A (From West of Markham Rd to East of Centennial College)

The City of Toronto will be undertaking restoration of Markham Branch of Highland Creek in order to protect exposed Sanitary Trunk Sewer and Maintenance Holes crossing the creek at several locations. This project is part of the Toronto City Council-approved 2011 Capital Works Program.

This work will take place from Markham Road and Progress Avenue to East of Centennial College. A map showing the work area is included below.

The restoration works will be performed in stages over three years as the length of the restoration is approximately 1.6km and consist of ...

1. Relocation of watermain East of Markham Rd.
2. Restoration of creek bed (riffle and pool structure with field stones)
3. Restoration of creek bank (Armour stone walls with brush layering)
4. Planting – some trees will be removed and replaced as part of the channel and flood plain reconstruction. This work was identified in the original 2007 approved environmental assessment study completed in consultation with the City's Urban Forestry, Toronto Region Conservation Authority, Department of Fisheries and Oceans and Ministry of Natural Resources.

Restoration Units 3 and 4 are presently under construction

You will be notified if there are any significant changes to the construction schedule or work to be undertaken.

Work Hours

Work will typically take place from 7:00 a.m. to 7:00 p.m. from Monday to Friday, with work after hours and on weekends as required.
